\_\_\_\_ **Dress code:** I understand and agree that ALL intimate body parts must be covered throughout the entire pageant. This code will go in accordance with any rule overlay by the Venue and/or the city/county in which the Venue is located.

\_\_\_\_ **Language and Conduct:** I understand and agree that the language and/or content of my presentations should be considered appropriate and not offensive to the general masses. If, at any time during the pageant, my material is considered not to be appropriate, the microphone and/or music will be turned off, the lights will go out or be dimmed and I will be disqualified from the pageant. If I am removed from the stage for inappropriate content of material/actions or wardrobe, I acknowledge that I will be disqualified from the current contest and may be asked to leave the Venue. I further acknowledge that I must meet with official Promoter, and Board of Directors of Miss Tampa Pride after the pageant, to discuss the incident and my future with Miss Tampa Pride.
